Job Prep: Our integrated JobPrep programs help youth and young adults chart a positive direction for their future. With guidance from trained staff, young people can attend employment readiness training, obtain industry-specific vocational credentials, be placed into paid work experience, receive college navigation and career coaching, as well as work with a case manager to assist in stabilizing their lives as they journey toward self-sufficiency. The vast majority of Tree Trust participants are "Opportunity Youth", young people who are not engaged in school or work, come from low-income households, and are at risk of not succeeding in employment or education. Tree Trust's JobPrep programs served 854 disadvantaged young people through five programs - YouthBuild, Young Adult Conservation Corp, Community Support Program,

Community Forestry: These programs educate and empower people of all ages to become good stewards of their local environment through planting and caring for trees. Through tree distributions and planting events in community parks, elementary schools, and residential properties, students and community volunteers learn about and connect with the environment. Tree Trust's Community Forestry program planted or distributed 3,209 trees & shrubs and worked with 616 volunteers and over 2,700 students during 15 events throughout the year.

Landscape Services: To help support Tree Trust's other programs and further the greening of the community, Tree Trust launched the Landscape Services division in 2004. The policy expands to cover all tree trust staff. Any potential conflicts at the staff level are reported to the executive director. The potential conflicts are then presented to the board by the executive director.
